2018 Inshore Racing Fleet Notice of Race

Series A: (1) February 18, (2) March 11, (3) March 25, 2018

Series B: (1) April 14, (2) April 29, (3) May 12, 2018

Series D: (1) August 26, (2) August 12 "Wahine Invitational"
(3) September 23, 2018

1. **RULES:** These races will be governed by the current year Racing Rules of Sailing (RRS); the US SAILING prescriptions excluding prescriptions to rules 60, 63.2 and 63.4; and the 2018 KYC Standing Sailing Instructions (available at KYC). Kaneohe Yacht Club is the organizing authority.
2. **ELIGIBILITY and ENTRIES:**
 - 2.1 The Series are open to monohull keel boats of 20 feet or more overall with a KYC PH Rating between 60 and 198. Exceptions may be at the discretion of the IRF fleet. Boats shall be owned or chartered by a member of KYC, or a Hawaii Yacht Racing Association affiliated organization.
 - 2.2 If not the owner, the person in charge (skipper) must be a current member of a sailing organization recognized by US Sailing or World Sailing.
 - 2.3 Boats may enter by completing an entry form, available at KYC, and submitting it with the required fees to KYC by 1000 on race day.
3. **FEES:** The Entry Fee is \$175 for the IRF Season (Series A, B, C 'Summer Circuit', and D), or \$20 Daily.
4. **SCHEDULE OF EVENTS:**
 - 4.1 There will be a Skippers' meeting at the KYC Entry Lounge on February 18, 2018 only.
 - 4.2 The Warning Signal will be at 1155 each day for the first class to start race 1. Races 2 and 3 will be started shortly after the last finisher in the prior race.
5. **COURSES:** The racing area will be on Kaneohe Bay east of Moku O Lo'e (Coconut Island) with courses indicated in the manner described in the 2018 KYC Standing Sailing Instructions.
6. **SCORING:** Three race scores will be discarded nine races of a series are completed. This amends RRS Appendix A.
