## NOTICE OF RACE 2019 Dillingham & Kanewai Races

Thursday, July 4, Dillingham Race-Waikiki to Kaneohe  
Sunday, July 7, Kanewai Race-Kaneohe to Waikiki

### 1. RULES:

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2. The prescriptions of US Sailing will apply, except that the US Sailing Prescriptions to RRS 60, 63.2 and 63.4 will not apply.
- 1.3. RRS No. 55 does not apply for spinnaker stopping materials only. It still applies to trash.
- 1.4. WORLD SAILING OFFSHORE SPECIAL REGULATIONS (for 2018-2019) SECTION 2 – APPLICATION & GENERAL REQUIREMENTS 2.01.06 Special Regulations will apply (See Appendix B - Short races, close to shore in relatively warm or protected waters normally held in daylight).
- 1.5. Advertising will not be restricted.
- 1.6. All boats shall carry an operating VHF radio, channel 68 will be used.
- 1.7. Kaneohe Yacht Club (KYC) is the organizing authority.

### 2. ELIGIBILITY, ENTRY, and FEES:

The races are open to monohull keel boats owned or chartered by members of HYRA clubs possessing a valid HYRA PHRF handicap. Other boats may be invited by the organizing authority.

- 2.1. Eligible boats may enter by completing the entry form and submitting it KYC Regatta Chair prior to 1830 Wednesday, July 3.
- 2.2. No entry fee required for the regattas on July 4 and 7.

### 3. CLASSES:

Classes X, A, B and Aloha as defined by HYRA. A Minimum of three (3) entries by 1830 Wednesday July 3 will be required to establish a class.

### 4. SCHEDULE of EVENTS:

- 4.1 Skippers' Meetings – There will be no skippers meeting for the Dillingham Race and the skippers meeting for the Kanewai Race will be at KYC on Thursday, July 4 at 8:30 AM.
- 4.2 Starting Time: First Warning for Aloha class will be as indicated below. X, A, B will follow shortly thereafter.

5. **SAILING INSTRUCTIONS:** The Sailing Instructions will be available on the Kaneohe Yacht Club website and at Kaneohe Yacht Club after July 2.

6. **VENUE and COURSES:** The courses will be on the coastal waters of Oahu. Refer to the Sailing instructions for each day's race.

7. **SCORING:**

7.1 The Low Point Scoring System, Appendix A4.1 will apply, except that no race scores will be excluded. This modifies Rule A2.

7.2 The results will not be used in HYRA Oahu Season's Points Scoring or to determine the winner of the Kalakaua Cup.

**BERTHING:** To facilitate mooring arrangements at KYC visiting boats must provide LOA, beam and draft data on their entry form. Contact the KYC Port Captain at 808-650-4192.
