### **2019 EI Toro Hawaii State Championship**

**Saturday, July 27, 2019**

**NOTICE OF RACE (issued 7/5/2019)**

#### **ORGANIZING AUTHORITY: Kaneohe Yacht Club (KYC)**

1. **RULES:** The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS 2017-2020), the prescriptions of US Sailing, the EI Toro International Yacht Racing Association (ETIYRA) Class rules, except as any of these are altered by the sailing instructions.
2. **ADVERTISING:** Advertising will be restricted to Category A.
3. **ELIGIBILITY AND ENTRY:**
  - 3.1 The regatta is open to all boats of the EI Toro Class that meet the Class requirements for racing.
  - 3.2 The Junior Division, sailors must be less than 19 years of age as of January 31, 2019
  - 3.3 The Senior Division, sailors must be 19 years of age or older as of January 31, 2019
  - 3.4 To qualify for Hawaii State honors, entrants must be residents of Hawaii.
  - 3.5 To qualify for Region V honors, entrant must be member in good standing of the EI Toro Association, and must be resident of Hawaii.
  - 3.6 Entries from residents of other states will be accepted but will not be eligible for Hawaii State or Region V honors.
  - 3.7 Each boat must have a sail number unique to that boat and displayed on both sides of the sail.
  - 3.8 Registration will be on-site only. See attached Entry Form.
4. **FEES:** Entry fee: \$15.00, with a \$5.00 discount to US Sailing members
5. **SCHEDULE:** All events are scheduled for Saturday, July 27, 2019

A total of six races will be attempted, conditions permitting.
6. **SAILING INSTRUCTIONS:** The Sailing Instructions will be available at Registration.
7. **VENUE:** The event will take place at Kaneohe Yacht Club with sailing on the water immediately to the west of the club.
8. **SCORING:**
  - 8.1 Appendix A – Scoring A2 Series Score will apply, except that when less than 5 races are completed that be no score will be excluded.
  - 8.2 Appendix A – Scoring A4 Low Point System will apply.
9. **AWARDS AND PRIZES:** Perpetual trophies are awarded to the first place Senior and Junior in both the Hawaii State and Region V categories. Prizes will be awarded for the first through third place in both Senior and Junior Divisions as well as a training sail junior division. The presentation will be at the HYRA Banquet.
