### **2019 Inshore Racing Fleet Notice of Race**

**Series A:** (1) February 17, (2) March 10, (3) March 31, 2019

**Series B:** (1) April 28, (2) May 19, (3) July 14, 2019

**Series D:** (1) July 20 "Wahine Invitational" (2) August 18  
(3) October 27, 2019

- 1. RULES:** These races will be governed by the current year Racing Rules of Sailing (RRS); the US SAILING prescriptions excluding prescriptions to rules 60, 63.2 and 63.4; and the 2019 KYC Standing Sailing Instructions (available at KYC). Kaneohe Yacht Club is the organizing authority.
- 2. ELIGIBILITY and ENTRIES:**
  - 2.1** The Series are open to monohull keel boats of 20 feet or more overall with a KYC PH Rating between 60 and 198. Exceptions may be at the discretion of the IRF fleet. Boats shall be owned or chartered by a member of KYC, or a Hawaii Yacht Racing Association affiliated organization.
  - 2.2** If not the owner, the person in charge (skipper) must be a current member of a sailing organization recognized by US Sailing or World Sailing.
  - 2.3** Boats may enter by completing an entry form, available at KYC, and submitting it with the required fees to KYC by 1000 on race day.
- 3. FEES:** The Entry Fee is \$175 for the IRF Season (Series A, B, C 'Summer Circuit', and D), or \$20 Daily.
- 4. SCHEDULE OF EVENTS:**
  - 4.1** There will be a Skippers' meeting at the KYC Entry Lounge on February 17, 2019 only.
  - 4.2** The Warning Signal will be at 1155 each day for the first class to start race 1. Races 2 and 3 will be started shortly after the last finisher in the prior race.
- 5. COURSES:** The racing area will be on Kaneohe Bay east of Moku O Lo'e (Coconut Island) with courses indicated in the manner described in the 2019 KYC Standing Sailing Instructions.
- 6. SCORING:** Three race scores will be discarded nine races of a series are completed. This amends RRS Appendix A.
